

TRI-STATE SELECT HORSE SALE SALE TERMS

Sale Terms:

We request that all prospective buyers report to our office and make known their intention to bid (all buyers must have a buyer's number to bid) and furnish bank references and copy of photo ID if purchase is to be made by check. Issuing a check with insufficient funds is a felony and will be handled as such. U.S. funds only. Other acceptable payment is cash, check and/or credit cards +3.5% charge. If paying by check, registration papers will be held for 5 business days and then mailed to the buyer. All horses must be paid for day of sale and removed from premises day of sale.

The sale company acts as selling agency only between the buyer and seller. It makes no representation or warranties whatsoever as to the livestock being sold. There is no guarantee of any horse sold in this sale except when the owner makes a specific guarantee, in such case, right of recourse must be directed to the seller. Seller must guarantee their horse to be 100% sound or must disclose any problems at time of sale including but not limited to: lameness, cribbing, weaving and vision.

All horses entered into to catalog but not offered for auction at the sale will incur a \$500 fee. In this case, the consignor gives the sale company the right to charge the same CC used to submit consignment to the catalog. Consignor may substitute a horse with a veterinarian's statement sent prior to sale day.

All horses selling on registration applications or bred mares without breeders certificates sell without any warranty or guarantee on papers - They sell "as-is." It is the buyer's responsibility to check registration papers before removing horses from the premises. The sale company will not accept responsibility. Horses will be cared for to the best of our ability. However, we will not be responsible for sickness, accident or death.

All horses must have negative Coggins dated within 1 year at arrival. The Sale veterinarian will be available to Coggins test horses upon arrival \$35.00. All horses leaving Missouri must obtain a health paper to leave the state. Seller checks will be available immediately following the sale. Absolutely no alley trading. No transit horses. Data provided in this listing is generally correct, but occasional errors due to incorrect data received from others, processing mistakes and other causes, therefore the sale company is not liable for such errors.

Consignor Fees:

Sale Fees include 8% commission (\$25.00 minimum) on all horses consigned to Tri-State Select Horse Sale and \$125 consignment fee paid at the time of consignment. Consignment fee still applies to horses consigned day of the sale. \$100 Pass out fee. \$2.50 yardage. If you need access to paper consignment form, contact the F&T office at (573) 769-2237. It is to the sellers advantage to consign early for catalog advertisement of the horse.
